

Website privacy policy

This website is operated by EaCharterYacht.com. We take your privacy very seriously therefore we urge to read this policy very carefully because it contains important information about on:

- who we are,
- how and why we collect, store, use and share personal information,
- your rights in relation to your personal information, and
- how to contact us and supervisory authorities in the event that you have a complaint.

Who we are

EaCharterYacht.com ('we' or 'us') (trading as Earl Associates & Michael John D. Earl, Greece) collect, use and are responsible for certain personal information about you. When we do so we are regulated under the General Data protection Regulations which apply across the European Union and includes the United Kingdom and we are responsible as 'controller' of that personal information for the purposes of those laws.

The personal information we collect and use

a) Personal information you provide to us

We collect the following personal information that you provide to us:

Full Name
Email Address + Mobile Telephone Number
Town/ City + Post Code or ZIP Code, Country
Requirements - Guest Numbers, Destination etc.

Further information such as Date of Birth, Home Address, Nationality, Passport Number & Place of Issue may be requested later, as part of a Charter Contract and Passenger List to comply with Greek Charter Laws.

Some examples of when we collect this information include:

Information is provided when making an enquiry about a Yacht Charter, Day Trip, or Transfer and /or creating a Charter Contract in compliance with Greek Charter Law.

b) Personal information you provide about third parties

If you give us information about another person, you confirm that the other person has appointed you to act on their behalf and agreed that you:

shall consent on their behalf to the processing of their personal data;
shall receive any data protection notices on their behalf; and
shall consent on their behalf to the transfer of their personal data abroad.

How we use your personal information

We collect information about our users for the following purposes:

Information is used only to provide an accurate quotation to Customers / Guests.
The same information may be used later as part of an Invoice, or Receipt, for services.
The information may be used later in analysis to determine advertising effectiveness
Further information such as Date of Birth, Home Address, Nationality, Passport Number & Place of Issue may be requested later, as part of a Charter Contract and Passenger List to comply with Greek Charter Laws.

Who your information may be shared with

We may share your information with:

Law enforcement agencies in connection with any investigation to help prevent unlawful activity
Hellenic Coastguard / Greek Port Police

We will not share your personal information with any other 3rd parties.

Marketing

In future we may wish to send you information about products, services, offers, competitions and our business which may be of interest to you. Such information could be sent by post, email, telephone, text message or automated call. You will be given to opportunity to opt out of such marketing information. We will ask whether you would like us to send you marketing messages on the first occasion that you provide any relevant contact information (i.e. on purchase, signing up to a newsletter, entering a competition etc). If you do opt in to receive such marketing from us you can opt out at any time (see 'What rights do you have?')

below for further information). If you have any queries about how to opt out, or if you are receiving messages you do not want you can contact us using the details provided below.

Whether personal information has to be provided by you, and if so why

No personal information has to be provided by you to us at any time except that required to provide you with a request for information and a quotation.

How long your personal information will be kept

We will hold your personal information for the following periods:

Names & Addresses - these are retained by the Greek Coastguard (and therefore us as well) for a currently undefined period
We will retain email addresses for future marketing unless you have opted out of receiving future emails from us.
We do not at present provide any information to Third Parties except that as required by law. eg Hellenic Coastguard

Reasons we can collect and use your personal information

We rely on the following as the lawful basis on which we collect and use your personal information:

Contract Law. Legal Obligation

Consequence of our use of your personal information

The consequence to you of our use of your personal information is:

You may in future be presented with advertising on our website(s) that has been tailored specifically to your stated requirements, or geographic location

Keeping your information secure

We have appropriate security measures in place to prevent personal information from being accidentally lost, or used or accessed in an unauthorised way. We limit access to your personal information to those who have a genuine business need to know it. Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality.

We will also use technological and organisation measures to keep your information secure. These measures may include the following examples:

No information is stored on this website (EaCharterYacht.com) and all information is encrypted by SSL

We also have procedures in place to deal with any suspected data security breach. We will notify you and any applicable regulator of a suspected data security breach where we are legally required to do so.

Indeed, while we will use all reasonable efforts to secure your personal data, in using the site you acknowledge that the use of the internet is not entirely secure and for this reason we cannot guarantee the security or integrity of any personal data that are transferred from you or to you via the internet. If you have any particular concerns about your information, please contact us using the details below.

Transfers of your information out of the EEA

We will not transfer your personal information outside of the EEA at any time.

What rights do you have?

Under the General Data Protection Regulation you have a number of important rights free of charge. In summary, those include rights to:

- fair processing of information and transparency over how we use your use personal information
- access to your personal information and to certain other supplementary information that this Privacy Notice is already designed to address
- require us to correct any mistakes in your information which we hold
- require the erasure of personal information concerning you in certain situations
- receive the personal information concerning you which you have provided to us, in a structured, commonly used and machine-readable format and have the right to transmit those data to a third party in certain situations
- object at any time to processing of personal information concerning you for direct marketing
- object to decisions being taken by automated means which produce legal effects concerning you or similarly significantly affect you
- object in certain other situations to our continued processing of your personal information
- otherwise restrict our processing of your personal information in certain circumstances
- claim compensation for damages caused by our breach of any data protection laws

How to complain
